

# ZBaby Gear

## RENTAL AGREEMENT

Renter rents from Z Baby Gear the items listed on the separate Order Form and agrees to the prices and terms on the separate Order Form.

**Location of Use:** Unless otherwise agreed, the rented items shall be used at or in relation to the Delivery Address specified on the separate Order Form.

**Damages and Use in Accordance with Instructions:** Renter is responsible for the loss or damage (excepting normal wear and tear) of the rented property. In the event of loss or damage, Renter agrees to pay the owner the fair value of replacement or repair. Products that are returned excessively dirty will be charged a \$20.00 cleaning fee.

When applicable, Renter will receive Manufacture's Instruction Documents. Renter is responsible for ensuring that items are used in accordance with these Instructions. Renter is responsible for the return of the Instruction Documents.

**Car Seat Installation:** Z Baby Gear is not allowed to install a car seat for you. We can provide contact information for several local car seat installers, and there is no cost for their service.

**Rental Extension:** Z Baby Gear Rentals cannot guarantee that the rental period can be extended, however we will do our best to accommodate your situation.

**Cancellation:** We need 48 Hours to cancel an order. Absent extenuating circumstances, orders that are cancelled less than 48 hours before scheduled delivery will be charged a 20% cancellation fee.

**Crib Set Up:** All full size cribs must be delivered and installed by Z Baby Gear. Full size cribs are not available for porch pick up.

**Special Trip Fee:** A special trip fee may be charged if an additional trip is required to resolve a problem that is not the fault of Z Baby Gear.

## RELEASE OF LIABILITY

Renter understands that there exist certain risks of serious injury from the use or misuse of items that are being rented.

Renter is responsible for reading and following special instructions or manufacturers instructions that accompany rental items and assumes all risks, known and unknown, associated with the use of a rented item.

Renter releases Z Baby Gear and it's owners (hereafter referred to as "ZBG") from, and agrees to hold ZBG harmless from, any liability for any injury or loss arising from the use or misuse of the rented items except for any injury or loss that might be found to be the result of ZBG's gross negligence or wanton misconduct.

Under no circumstances will ZBG be held responsible for any damage, injury, or loss, including death, arising from the failure of the equipment to function as intended by the manufacturer.

Renter has read and understands all parts of this Rental Agreement including the Release of Liability. Renter understands that Renter may have given up substantial rights by signing this Agreement and Renter freely and voluntarily signs the Agreement without inducement.
